April 7, 2021: Meeting was called to order by Kyle Martin with 9 members present and 1 member via Zoom meeting. Introductions were done and a motion was made to approve the minutes motion seconded and passed.

OLD BUSINESS:

Damage Prevention Board:

A meeting was held on 3/11 with no action items on the agenda. The billboards are up throughout the state in approximately 17 locations. The plan is to increase the billboards budget for next year as it seems to be a good way to get the word it to call before you dig. Currently a committee is looking into extending the time frame of a locate from 3 to 4 weeks so long as the marks are maintained. They are also discussing emergency locates and how to handle call that are said to be an emergency but are not really an emergency. More to follow on those topics.

Funding was in the budget so the approval was given to purchase those items and any other small items that might be needed.

The Home & Garden Shows is scheduled for April 23-25, we have reserved the same booth location as last year. A sign up sheet was passed around for volunteering to work the booth, we still have spots we need filled so if you can help please lets us know.
