**OCC Report:** 3,283 normal tickets and 52 emergency tickets for a total of 3,335. The year to date total is 6,757 tickets which is a 6.8% decrease from last year. 1,826 tickets were done via the web (ITIC) which is 54.7% of all tickets. OCC asked if the council would be interested in voluntary positive response, the council is interested and we will check with Digline on what codes they are using in Southern Idaho. Discussion was also had about using a Safety locate ticket for when someone finds someone digging without a locate they could call in a ticket so other utilities would be informed of the dig location. More to follow as we gather more information.
